Status of Indicator light

1-Indicator

Green light flashes when radio is receiving. Red light flashes when radio is transmitting. The green light flashes about every 3 seconds while waiting.

2-Channel Switch

5 channels available, choosing the desired channel to communicate from 1-5 numbers by channel knob switch.

3-Power Switch

Rotating the volume knob reduces/increases volume level and switching power supply.

4-PTT

Over the side of the radio is the PTT switch.Press PTT and face to the microphone to communicate with the others while red light indicating.

5-Monitor

When the side key is set as the monitor key according to the write frequency software, short press once to open monitor function, and short press again to close monitor function.

6-Squelch level

The purpose of the squelch is to mute the speaker when no signals are present. Lower squelch level ,high background noise hear , longer communication range ,weaker the anti-inference . Default squelch level is 5 and can be programmed level 0-9 by PC . Level 0 is to open the squelch. The higher the selected squelch level, the stronger the signals must be when receiving

7-TOT

This function can prevent users from occupied the present channel for a long time and limit TX time, meanwhile prevent the radio from damage by long time transmitting

If radio continues TX over the limit time (set by the programming software), the radio will quit TX and sounds a warning sound. To stop warning sound, release the PTT, the radio will back to the receiving state. When TX over time, through the bell to carry out the early warning in advance(setting by program software)

8-Voice annunciation

Please choose the desired language by PC programming software.

9-Power Saving Function

Please select to enable or disable the power save function by PC program software.

10-Battery Voltage Alert

When the battery voltage is lower than a 3.1V, the voice will sound "please charge", and prohibit transmitting.

11-Busy Channel Lockout

If radio programmed with BCLO function, pressing PTT to prohibit TX after receiving the signal and accompanied by a long beep alarm sound

12-High /Low Power Switch

Radio default setting is high power . You can switch high /low power by PC programming software.

13-VOX

- 1. VOX allows you to transmit using the voice of your speech without pressing the PTT transmitter key, and automatically stop transmitting after speaking. Select the side key as VOX function through RB17V write frequency software.
- 2. When the write frequency software has enabled your walkie-talkie side key as VOX function. Short press the side key once with "di" to turn off the VOX, and again with "di di" to turn on the VOX.Talking to the microphone, then the voice will be sent out; Stop talking, then the radio will be in receiving state
- 3. To use the VOX function, you must adjust the VOX gain in the write frequency function, and set the VOX gain so that the walkie-talkie can identify the sound volume. If the microphone is too sensitive, the noise will activate transmitting: if the microphone is not sensitive enough, your

voice will not activate transmitting. In order to communicate successfully, please adjust the appropriate level NOTE: If the speaker/microphone is connected to the intercom while VOX is on and the VOX gain is set to a higher and more sensitive level, the received signal amplified by the speaker/

14-QT/DQT

You can set the CTCSS/DCS by PC programming software. When the channels are set the CTCSS/DCS, squelch can be turned on when received a signal with the same

microphone may cause the intercom to start transmitting

CTCSS/DCS. The two radios can talk with each other, If the same channel uses a different QT/DQT, the squelch can not be turned on and the light will be green. The two radios can't talk with each other

QT :(total 50) DQT:(total 116*2)

15-Local alarm function

Press the alarm button on the top of the radio. At this time, the radio will send out the alarm sound. When press it again, the alarm turns off

16-Compandor

RB17V write frequency software can be used to open the compandor function. When the function is opened, the background noise will be suppressed to a certain extent, but the high frequency components of the intercom sound will be lost a little.

Troubleshooting

RF ENERGY EXPOSURE AND PRODUCT SAFETY GUIDE FOR PORTABLE TWO-WAY RADIOS



Before using this radio, read this guide which contains important operating instructions for safe usage and RF energy awareness and control for compliance with applicable standards and regulations.

This two-way radio uses electromagnetic energy in the radio frequency (RF) spectrum to provide communications between two or more users over a distance. RF energy, which when used improperly, can cause biological damage.

All Retevis two-way radios are designed, manufactured, and tested to ensure they meet government-established RF exposure levels. In addition, manufacturers also recommend specific operating instructions to users of two-way radios. These instructions are important because they inform users about RF energy exposure and provide simple procedures on how to control it

Local Government Regulations

When two-way radios are used as a consequence of employment, the Local Government Regulations requires users to be fully aware of and able to control their exposure to meet occupational requirements. Exposure awareness can be facilitated by the use of a product label directing users to specific user awareness information. Your Retevis two-way radio has a RF Exposure Product Label. Also, your Retevis user manual, or separate safety booklet includes information and operating instructions required to control your RF exposure and to satisfy compliance requirements.

Radio License

Governments keep the radios in classification, business two-way radios operate on radio frequencies that are regulated by the local radio management departments (FCC, ISED, OFCOM, ANFR, BFTK, Bundesnetzagentur...). To transmit on these frequencies, you are required to have a license issued by them. The detailed classification and the use of your two radios, please contact the local government radio management departments.

Use of this radio outside the country where it was intended to be distributed is subject to government regulations and may be prohibited.

- •User awareness instructions should accompany the device when transferred to other users.
- •Do not use this device if the operational requirements described herein are not met.

Operating Instructions:

- Transmit no more than the rated duty factor of 50% of the time. To Transmit (Talk), push the Push to Talk (PTT) button. To receive calls (listen), release the PTT button. Transmitting 50% of the time, or less, is important because the radio generates measurable RF energy exposure only when transmitting in terms of measuring for standards compliance.
- Transmit only when people outside the vehicle are at least the recommended minimum lateral distance away from a properly installed according to installation instructions, externally mounted antenna.
- When operating in front of the face, worn on the body, always place the radio in a Retevis approved clip, holder, holster, case, or body harness for this product. Using approved body-worn accessories is important because the use of Non-Retevis approved accessories may result in exposure levels, which exceed the IEEE/ICNIRP RF exposure limits.

Hand-held Mode

Hold the radio in a vertical position with the microphone (and other parts of the radio including the antenna) at least 2.5 cm (one inch) away from the nose or lips. The antenna should be kept away from the eyes. Keeping the radio at a proper distance is important as RF exposure decreases with increasing distance from the antenna.

Phone Mode

• When placing or receiving a phone call, hold your radio product as you would a wireless telephone. Speak directly into the microphone.

Electromagnetic Interference/Compatibility

NOTE: Nearly every electronic device is susceptible to electromagnetic interference (EMI) if inadequately shielded, designed, or otherwise configured for electromagnetic compatibility.

Avoid Choking Hazard



Small Parts. Not for children under 3 years.

Turn off your radio power in the following conditions:



- •Turn off your radio before removing (installing) a battery or accessory or when charging battery.
- •Turn off your radio when you are in a potentially hazardous environments: Near electrical blasting caps, in a blasting area, in explosive atmospheres (inflammable gas, dust particles, metallic powders, grain powders, etc.).
- •Turn off your radio while taking on fuel or while parked at gasoline service stations. To avoid electromagnetic interference and/or compatibility conflicts
- •Turn off your radio in any facility where posted notices instruct you to do so, hospitals or health care facilities (Pacemakers, Hearing Aids and Other Medical Devices) may be using equipment that is sensitive to external RF energy.
- •Turn off your radio when on board an aircraft. Any use of a radio must be in accordance with applicable regulations per airline crew instructions.

Protect your hearing:

- · Use the lowest volume necessary to do your job.
- Turn up the volume only if you are in noisy surroundings.
- Turn down the volume before adding headset or earpiece.
- Limit the amount of time you use headsets or earpieces at high volume.
- When using the radio without a headset or earniece, do not place the radio's speaker directly

against your ear

Use careful with the earphone maybe possible excessive sound

pressure from earphones and headphones can cause hearing loss

Note: Exposure to loud noises from any source for extended periods of time may temporarily or permanently affect your hearing. The louder the radio's

volume, the less time is required before vour hearing could be affected. Hearing damage from loud noise is sometimes undetectable at first and can have a cumulative effect.

Avoid Burns



Antennas

 Do not use any portable radio that has a damaged antenna. If a damaged antenna comes into contact with the skin when the radio is in use, a minor burn can result

Batteries (If appropriate)

-When the conductive material such as jewelry, keys or chains touch exposed terminals of the batteries, may complete an electrical circuit (short circuit the battery) and become hot to cause bodily injury such as burns. Exercise care in handling any battery, particularly when placing it inside a pocket, purse or other container with metal objects

Long transmission

•When the transceiver is used for long transmissions, the radiator and chassis will become hot.

Safety Operation



Forbid

•Do not use charger outdoors or in moist environments, use only in dry locations/conditions.

- •Do not disassemble the charger, that may result in risk of electrical shock or fire.
- •Do not operate the charger if it has been broken or damaged in any way.
- •Do not place a portable radio in the area over an air bag or in the air bag deployment area. The radio may be propelled with great force and cause serious injury to occupants of the vehicle when the air bag inflates.
