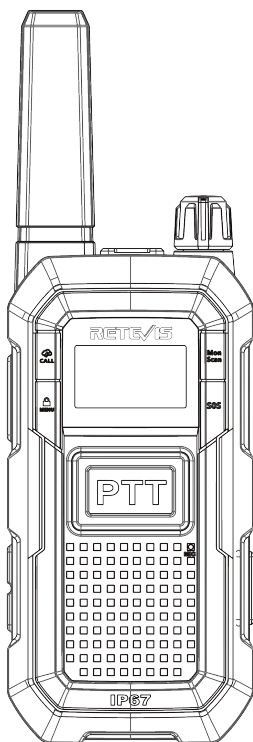

Notes of charging:

Please use the matching charging base or Type-C charging cable to charge.

Please make sure the radio is turned off when charging.

In order to get the best battery performance, please charge for at least 5 hours for the first time.

Please do not charge the battery for a long time, otherwise the service life of the battery will be shortened. When the battery is fully charged, please stop charging in time.

The charger is only charged for this radio battery, please do not charge other battery, otherwise it will cause damage to the charger and battery.

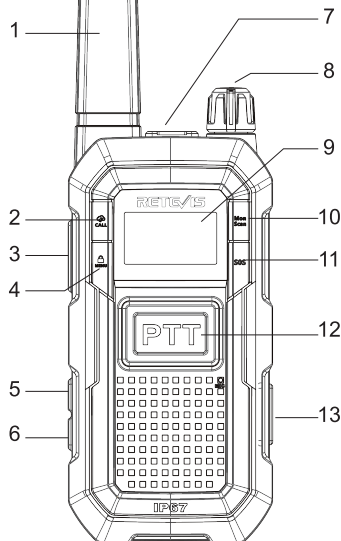
After the battery is fully charged, please place it in a cool, dry place. Please do not get close to fire or expose to sunlight, otherwise there will be a safety hazard.

During the radio charging, it is not recommended to transmit.

During the radio charging, the battery will be slightly hot, which is normal.

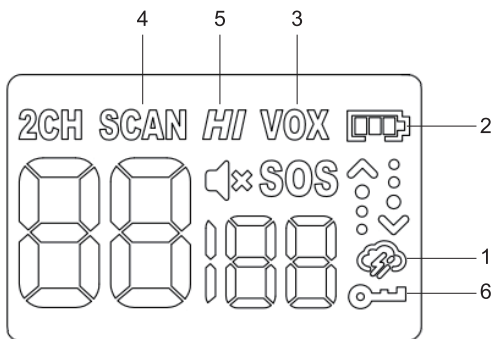
Radio introduction

1. Antenna
2. Call tone for short press
(need to select the type of call tone)
NOAA for long press (US version)
3. PTT
4. Short press to enter the menu function
Long press to open the key lock (US version)
5. Up
6. Down
7. Earpiece Jack
8. Volume/Power Switch
9. LED display
10. Short press to switch scan function
(It needs to click the scan function in the software)
Long press to switch monitor
11. Alarm
12. PTT
13. Type-c

Function operation

1. Turn on/off

1.1 Turn the power switch clockwise to turn on the radio, the radio will sound a power-on prompt and all icons will be displayed in full screen when the radio is turned on. After the radio is turned on, the default mode of the radio is in direct call mode, displaying the currently used channel and CTC/DCS, etc.

1.2 When turning off the radio, turn the power switch counterclockwise until a click sounds.

2. Volume adjustment

In standby or receiving state, turn clockwise to increase the volume, counterclockwise to decrease the volume, 1-9 levels of volume can be adjusted cyclically.

Note:

When the volume is not adjusted to a suitable state, please do not put the radio speaker too close to the ear to avoid the sound being too loud and hurting the hearing.

3. Transmit/Receive

3.1 In standby mode, press and hold the transmit button [PTT] to speak. When the transmit icon is displayed, it means that the call is being sent. To avoid cutting off your call content, please press the [PTT] key for a short pause, and then start speaking.

3.2 Release the transmit button [PTT] can receive the signal sent from the same channel, the speaker emits the call sound, and when receiving, the receive icon will be displayed.

Note:

1) When the radio is transmitting, please keep the radio in a vertical position and keep the microphone 3-5cm away from the mouth. When transmitting, please keep the radio at least 3 cm from the head or body.

2) During use, there is no need to perform multiple power-on and power-off actions, and at the same time adjust the volume to a volume suitable for your hearing.

3) Before calling on radio, please set the frequency of the transmitter and receiver to the same.

4) Please set the CTC/DCS of the transmitter and receiver for the channel you want to talk to to be the same.

4. Set the channel

4.1 In the standby state of direct call mode, press the [MENU] key once, the current channel will flash.

4.2 Press [▲] or [▼] key to select the channel you want to set.

4.3 Press the [PTT] key to save the current setting and exit the menu or press the [MENU] key to jump to the next menu setting.

4.4 The radios can only communicate when they are set to the same channel, and the sound is clear, no noise.

5. CTC/DCS selection

This product supports a total of 121 groups of CTC/DCS, 38 groups of analog sub-tone codes and 83 groups (N-phase and I-phase) digital sub-tone codes can be set through software (CPS).

5.1 In the standby state of direct call mode, press the [MENU] key twice, the current CTC/DCS setting will flash.

5.2 Press [▲] or [▼] key to select the CTC/DCS you want to set. Press and hold the [▲] or [▼] key to quickly switch the CTC/DCS.

5.3 Press the [PTT] key to save the current setting and exit the menu or press the [MENU] key to jump to the next menu setting.

6. High/low power setting

6.1 In the standby state of direct call mode, press the [MENU] key 5 times, and "Pr" will be displayed on the screen.

6.2 Press [▲] or [▼] key to select power LO or HI. (LO: low power / HI: high power)

6.3 Press [PTT] key to save the current setting and exit the menu

7. TOT function

When you press and hold the [PTT] key continuously to talk for more than 15-600 seconds, the radio will emit a continuous warning tone, the radio will stop transmitting automatically.

8. Set Call Tone

8.1 In the standby state of direct call mode, press the [MENU] key 3 times, the setting screen of the current call tone will flash "CA".

8.2 Press [▲] or [▼] key to select the call tone you want to set, and the radio speaker will emit the corresponding call tone at the same time.

8.3 Press the [PTT] key to save the current setting and exit the menu or press the [MENU] key to jump to the next menu setting.

Note: When the call tone menu setting is selected as 0, the call function will be invalid when long press the [CALL] key.

9. Roger Beep

This product supports the Roger Beep function, which can send a sound to remind the receiver that the transmission has ended.

9.1 In the standby state of direct call mode, press the [MENU] key 7 times, and "rb" will be displayed on the screen.

9.2 Press[▲]or[▼]key to select ON and OFF

9.3 Press[PTT]key to save the current settings and exit the menu

9.4 After the function is turned on, there will be a prompt tone after the radio is finished transmitting.

10. Button Function

10.1 [SOS] key: long press this key to turn on the alarm function, press the PTT key to stop

10.2[CALL] key: long press this key to switch between direct call and NOAA weather mode; short press this key to transmit call tone

10.3 [SCAN] key: long press this key to start listening; short press this key to start scanning

10.4 [MENU] key: long press this key to operate the lock or unlock function; short press this key to enter or exit the menu

10.5[▲]key: short press up

10.6[▼]key: short press down

10.7[PTT] key : transmit or save settings (in menu mode)

11. key lock function

The keyboard lock function is to prevent users from misoperation when they do not want to change the settings of the radio.

11.1 Press and hold the [MENU] key until the lock icon appears to enter the keyboard lock state.

11.2 Press and hold the [MENU] key until the lock icon disappears to exit the keyboard lock state.

Note: When the keyboard is locked, a key failure tone will be emitted when any key is pressed except for the [PTT] key.

12. channel scan

12.1 In the standby state, press the [MENU] key 6 times, and the screen will display "SC".

12.2 Press[▲]or[▼]key to select ON and OFF

12.3 Press[PTT]key to save the current setting and exit the menu

12.4 The scanning function of the radio to scans the channels with valid signals, you can easily scan all channels
Note: When the scan menu setting is selected as OF, the scan function will be invalid when pressing the [SCAN] key.

13. Start scan:

13.1 Press the [SCAN] key in standby mode of direct call mode to enter the scan mode, the channel number will be displayed in an upward increment, and the [SCAN] icon will be displayed on the LCD.

13.2 When an active channel is detected, the radio automatically pauses to receive signals on this channel until the signal disappears. After the signal disappears for 5 seconds, the radio will continue to scan.

13.3 During the scanning process, press the [PTT] key, the radio will stop on the channel that entered the scan and transmit. If a valid signal is detected, the scan will stop and receive the signal, press the [PTT] key and the radio will transmit on the current channel scanned. After releasing the [PTT] key for 5 seconds, the radio will continue to scan

13.4 Press the [SCAN] key again to exit scan and return to the radio standby mode.

14. VOX function

When the VOX function is turned on, you do not need to press the [PTT] key to be able to talk, speaking directly into the microphone, calls will automatically transmit.

14.1 In the standby state of direct call mode, press the [MENU] key 4 times, VOX will be displayed on the screen, and the VOX level can be set.

14.2 Press[▲]or[▼]key to select sensitivity level 1-9:

9 = High sensitivity level

5= Medium sensitivity level

1 = Low sensitivity level

0 = OFF

14.3 Press the [PTT] key to save the current setting and exit the menu or press the [MENU] key to jump to the next menu setting.

Select sensitivity 0, turn off the VOX function, and the VOX icon will disappear.

14.4 Talk directly into the microphone and the call will be transmitted automatically. There is a brief delay between the start of speaking and the radio transmission.

14.5 Stop speaking, the radio can enter the receiving state.

15. Battery power display and low battery warning

The battery icon shows the power level, from full to empty (0). When the power level is 0, the user is prompted to charge in time, accompanied by a low battery reminder (once every 30 seconds). When the battery power is low, the radio will be turned off.

Note: When the radio is not used for a long time, you need to charge the radio from time to time.

16. Caller Vibration

16.1 In the standby state of direct call mode, press the [MENU] key 8 times, and the screen will display "U1".

16.2 Press[▲]or[▼]key to select ON and OFF

16.3 Press[PTT]key to save the current settings and exit the menu

16.4 After the function is turned on, the first incoming call in standby mode will vibrate to indicate

17. Power saving function

The radio has unique features to extend battery life. If there is no call or voice received within 10 seconds, the radio will automatically enter power saving mode. The radio can still receive in this mode.

18. NOAA Weather

The NOAA weather function is available in the U.S. and Canada as needed.

You can listen to the NOAA Weather Channel (For details, please refer to "the NOAA Weather Channel and Frequency" list). You cannot in scan mode or use radio communication when you need to listen to the NOAA Weather Channel

NOAA and Environment Canada both have transmitters throughout the U.S. and Canada. These transmitters broadcast 24 hours a day with forecasts and other information.

19. Enter NOAA Weather Mode

In direct call mode, press and hold the [CALL] button for 1 second to enter the NOAA weather mode.

Set the NOAA weather channel

Your radio receives NOAA weather frequencies:

19.1 In NOAA weather mode, press the [MENU] button until the NOAA weather channel number flashes.

19.2 Press the [▲] or [▼] button to select a suitable channel with good reception in your area.

19.3 Long press the [CALL] button to exit the menu.

20. Set NOAA Weather Alerts

Your radio can be set to respond to NOAA weather broadcast emergencies. A special alarm tone will sound the alarm and turn on the weather receiver to provide you with instant weather and emergency information.

20.1 In NOAA weather mode, press the [MENU] button twice, the weather forecast icon will be displayed.

20.2 Press[▲]or[▼]button to select ON/OFF.

20.3 Press the [MENU] button to exit the weather setting.

20.4 Press and hold the [CALL] button for 1 second to return to the direct call mode, if you turn on the NOAA weather alert and return to the direct call mode, the weather forecast icon will be displayed.

Note: After entering the NOAA weather channel, if you receive an alarm, press and hold the [CALL] button for 1 second, the NOAA weather mode will automatically return to channel mode

21. Headset function

21.1 Connect the headset accessories to the radio (radio A&B).

21.2 Press the [PTT] button on the headset of the radio A, sending a call to the MIC of the headset, and the radio B should be able to receive it normally. Repeat the same operation on radio B.

RF ENERGY EXPOSURE AND PRODUCT SAFETY GUIDE FOR TWO-WAY RADIOS



ATTENTION!

Before using this radio, read this guide which contains important operating instructions for safe usage and rf energy awareness and control for compliance with applicable standards and regulations.

- **User instructions should accompany the device when transferred to other users.**
- **Do not use this device if the operational requirements described herein are not met.**

This two-way radio uses electromagnetic energy in the radio frequency (RF) spectrum to provide communications between two or more users over a distance. RF energy, which when used improperly, can cause biological damage.

All Retevis two-way radios are designed, manufactured, and tested to ensure they meet government-established RF exposure levels. In addition, manufacturers also recommend specific operating instructions to users of two-way radios. These instructions are important because they inform users of RF energy exposure and provide simple procedures on how to control it.

When two-way radios are used as a consequence of employment, the Local Government Regulations requires users to be fully aware of and able to control their exposure to meet occupational requirements. Exposure awareness can be facilitated by the use of a product label directing users to specific user awareness information. Your Retevis two-way radio has a RF Exposure Product Label. Also, your Retevis user manual, or separate safety booklet includes information and operating instructions required to control your RF exposure and to satisfy compliance requirements.

Radio License(only applicable to licensed radio)

Governments keep the radios in classification, business two-way radios operate on radio frequencies that are regulated by the local radio management departments (FCC, ISD, OFCOM, ANFR, BFTK, Bundesnetzagentur...). To transmit on these frequencies, you are required to have a license issued by them. The detailed classification and the use of your two radios, please contact the local government radio management departments.

Use of this radio outside the country where it was intended to be distributed is subject to government regulations and may be prohibited.

Unauthorized modification and adjustment

Changes or modifications not expressly approved by the party responsible for compliance may void the user's authority granted by the local government radio management departments to operate this radio and should not be made. To comply with the corresponding requirements, transmitter adjustments should be made only by or under the supervision of a person certified as technically qualified to perform transmitter maintenance and repairs in the private land mobile and fixed services as certified by an organization representative of the user of those services.

Transmit no more than the rated duty factor of 50% of the time. To Transmit (Talk), push the Push to Talk (PTT) button. To receive calls (listen), release the PTT button. Transmitting necessary information or less, is important because the radio generates measurable RF energy exposure only when transmitting in terms of measuring for standards compliance.

•DO NOT operate the radio without a proper antenna attached, as this may damage the radio and may also cause you to exceed RF exposure limits. A proper antenna is the antenna supplied with this radio by the manufacturer or an antenna specifically authorized by the manufacturer for use with this radio, and the antenna gain shall not exceed the specified gain by the manufacturer declared.

•DO NOT transmit for more than 50% of total radio use time, more than 50% of the time can cause RF exposure compliance requirements to be exceeded.

•During transmissions, your radio generates RF energy that can possibly cause interference with other devices or systems. To avoid such interference, turn off the radio in areas where signs are posted to do so.

•DO NOT operate the transmitter in areas that are sensitive to electromagnetic radiation such as hospitals, aircraft, and blasting sites.

Hand-held Mode(if applicable)

• Hold the radio in a vertical position with the microphone (and other parts of the radio including the antenna) at least 2.5 cm (one inch) away from the nose or lips. The antenna should be kept away from the eyes. Keeping the radio at a proper distance is important as RF exposure decreases with increasing distance from the antenna.



Phone Mode(if applicable)

•When placing or receiving a phone call, hold your radio product as you would a wireless telephone. Speak directly into the microphone. Do not use the equipment when you are driving

Electromagnetic Interference/Compatibility

NOTE: Nearly every electronic device is susceptible to electromagnetic interference (EMI) if inadequately shielded, designed, or otherwise configured for electromagnetic compatibility.

Avoid Choking Hazard



Small Parts. Not for children under 3 years.

Turn off your radio power in the following conditions:



- Turn off your radio before removing (installing) a battery or accessory or when charging battery.
- Turn off your radio when you are in a potentially hazardous environments: Near electrical blasting caps, in a blasting area, in explosive atmospheres (flammable gas, dust particles, metallic powders, grain powders, etc.).
- Turn off your radio while taking on fuel or while parked at gasoline service stations. To avoid electromagnetic interference and/or compatibility conflicts

- Turn off your radio in any facility where posted notices instruct you to do so, hospitals or health care facilities (Pacemakers, Hearing Aids and Other Medical Devices) may be using equipment that is sensitive to external RF energy.
- Turn off your radio when on board an aircraft. Any use of a radio must be in accordance with applicable regulations per airline crew instructions.

Protect your hearing:



- Use the lowest volume necessary to do your job.
- Turn up the volume only if you are in noisy surroundings.
- Turn down the volume before adding headset or earpiece.
- Limit the amount of time you use headsets or earpieces at high volume.
- When using the radio without a headset or earpiece, do not place the radio's speaker directly against your ear
- Use careful with the earphone maybe possible excessive sound pressure from earphones and headphones can cause hearing loss

Note: Exposure to loud noises from any source for extended periods of time may temporarily or permanently affect your hearing. The louder the radio's volume, the less time is required before your hearing could be affected. Hearing damage from loud noise is sometimes undetectable at first and can have a cumulative effect.



Avoid Burns



Antennas

- Do not use any portable radio that has a damaged antenna. If a damaged antenna comes into contact with the skin when the radio is in use, a minor burn can result.

Batteries (If appropriate)

- When the conductive material such as jewelry, keys or chains touch exposed terminals of the batteries, may complete an electrical circuit (short circuit the battery) and become hot to cause bodily injury such as burns.
