Operation instructions:

1. [Power/Flashlight] button:

Press and hold for 3 seconds to turn on, double-click to turn on the flashlight, and then double-click to turn off the flashlight (the flashlight function can also be operated in the off state)

2. [PTT] button:

Press and hold to realize the intercom function when power on

3. Pairing Operation:

 [Power/Flashlight] and [PTT] buttons are pressed at the same time. the pairing interface appears as shown below.

• When two machines to be paired press the [Power/Flashlight] and IPTTI buttons at the same time the above displaywill appear, and then press the [Power/Flashlight] button to move between A and B, where A is the transmitter B For the receiving end, any machine can choose A or B, that is to say, any machine can be adjusted as the transmitting or receiving end according to your needs, short press the [PTT] button to confirm the selection of A or B such as a machine selection A is used as the transmitter, as shown in the figure below.

. Choose B as the receiver as shown in the figure below.

Short press the IPTTI button of machine Blagain, confirm to select the ID number of the transmitter A machine (AP DD42), each machine ID number is also unique. when multiple machines are turned on and enter the pairing together, the receiving machine will display For multiple ID numbers, short press the [Power/Flashlight] button to select different machines for pairing connection, and then press the IPTTI

button to confirm. After the above operations are completed, the selected machine will automatically connect and pair:

4. When plugged in to charge, the LCD display will display the charging icon, and i will enter a black screen for about 10 seconds. Under the black screen, short press the [Power/Flashlight] button to wake up the charging status: the battery icon is full indicating that the charging is complete, and the charging can also be performed at the same time during the power-on state. The charging icon is displayed in the lower left corner of the LCD:

Troubleshooting:

- 1. The communication distance is too far, beyond the communication range that can be sent and received.
- 2. The surrounding wireless environment is more complicated, and there are too many wireless devices nearby.
- 3. In the case of insufficient battery power, the communication distance will be shortened accordingly.

Attention:

- 1. If the machine does not respond for a long time, press and hold the reset button on the side for 2 seconds, and then restart
- 2. Use AAA Ni-MH rechargeable batteries or AAA alkaline dry batteries, which are not rechargeable.
